Punch Out Ballot Card ONLY With Punching Stylus, Which Is Attached To Chain; Never With a Pen or Pencil.

Instructions to Voters: To vote for a candidate or issue of your choice, punch the ballot card in the hole/number next to the right of the name or issue of your choice.

Do not punch for more than one candidate under each office title.

If you wrongly punch, tear or deface the ballot, return it to the election clerk and obtain another.

WRITE-IN

To vote for a person not on the ballot, you must write in the name of a valid write-in candidate and the office title in the space provided on the envelope in which you received your ballot.

Do not write on the ballot card or the ballot pages.
