

**NOTICE OF ELECTIONS
BONNEVILLE COUNTY, IDAHO**

As required by Section 34-602 of the Idaho Code, NOTICE IS HEREBY GIVEN that Bonneville County will be conducting the following elections listed below on Tuesday, March 12, 2019. The polls will be open from eight (8) a.m. to eight (8) p.m. Said elections will be conducted pursuant to Title 34 of the Idaho Code.

Idaho Falls School District No. 91 – Supplemental Levy Election:

Shall the Board of Trustees of School District No. 91 (Idaho Falls), Bonneville County, Idaho, be authorized and empowered to levy a supplemental levy, as permitted by law, in the amount of six million eight hundred thousand dollars (\$6,800,000), each year for two years for a total of thirteen million six hundred thousand dollars (\$13,600,000) for the purpose of paying all lawful expenses of maintaining and operating the schools of the District for the fiscal years beginning July 1, 2019, and ending June 30, 2021?

Ririe Joint School District No. 252 – Supplemental Levy Election:

Shall the Board of Trustees of Ririe Joint School District No. 252, Jefferson and Bonneville Counties, State of Idaho, be authorized and empowered to levy a supplemental levy, as permitted by law under Section 33-802(3), Idaho Code, in the amount of two hundred ninety thousand dollars \$290,000 each year for two years for the purpose of funding a portion of the lawful expenses of maintaining and operating the schools of the District for the fiscal years beginning July 1, 2019 and ending June 30, 2021?

Electors must have resided in the district at least thirty (30) days preceding the election. Early Voting is being conducted in the Bonneville County Elections Office at 825 Shoup Ave, Idaho Falls, weekdays eight (8) a.m. to five (5) p.m. through March 8, 2019. On Election Day, March 12, 2019, the precinct polling places in Bonneville County for these elections are as follows:
