PRECINCT	Shall the Board of Trustees of School District No. 91, (Idaho Falls), Bonneville County, Idaho, be authorized to levy a supplemental levy, as permitted by law in Section 33-802(3), Idaho Code, in the amount of six million eight hundred thousand dollars (\$6,800,000), each year for two years for a total of thirteen million six hundred thousand dollars (\$13,600,000) for the purpose of paying all lawful expenses of maintaining and operating the schools of the District commencing with the fiscal year beginning July 1, 2017 and ending June 30, 2019 as provided in the resolution of the Board of Trustees of School District No. 91 adopted on January 11, 2017?
