**BONNEVILLE COUNTY RESOLUTION NO. 00-03
IN THE MATTER OF THE PETITION FOR
ANNEXATION OF ADJOINING TERRITORY LOCATED
IN BONNEVILLE COUNTY TO THE CENTRAL FIRE
PROTECTION DISTRICT**

The Bonneville County Board of Commissioners, having received an order from the Central Fire District for annexation of certain territory located within Bonneville County, Idaho, and pursuant to the provisions of Idaho Code 31-1411,

NOW, THEREFORE, DO HEREBY ORDER that the territory herein after described, located within the county of Bonneville, Idaho, be and the same is hereby declared annexed to the Central Fire Protection District, Jefferson County, Idaho in accordance with the provisions of Idaho Code 31-1411 and the same are hereby fixed as follows:

Beginning at the Northwest corner of the southwest Quarter of Section 23, Township 3 North, Range 41 E.B.M.; thence south 6600 feet (1 ¼ mile) along the West Boundary of Sections 23 and 26, Township 3 North, Range 41 E.B.M. thence East 3960 feet (3/4 mile) to the Southeast corner of the Northwest Quarter of the Southeast Quarter, Section 26, Township 3 North, Range 41 E.B.M.; thence north 1320 feet (1/4 mile) to the Northeast corner of the Northeast Quarter of the Southeast Quarter, Section 26, Township 3 North, Range 41 E.B.M.; thence west 1320 feet (1/4 mile) to the Northwest corner of the Southeast Quarter, Section 26, Township 3 North, Range 41 E.B.M.; thence north 5280 feet (1 mile) to the Northeast corner of the Southwest Quarter of Section 23, Township 3 North, Range 41 E.B.M.; thence West 2640 feet (1/2 mile) back to the point of beginning for this annexation.

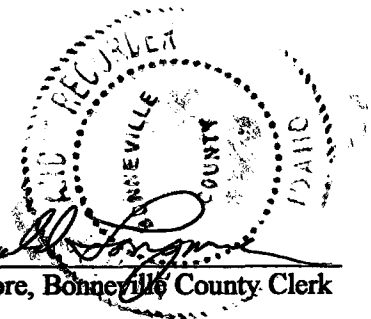

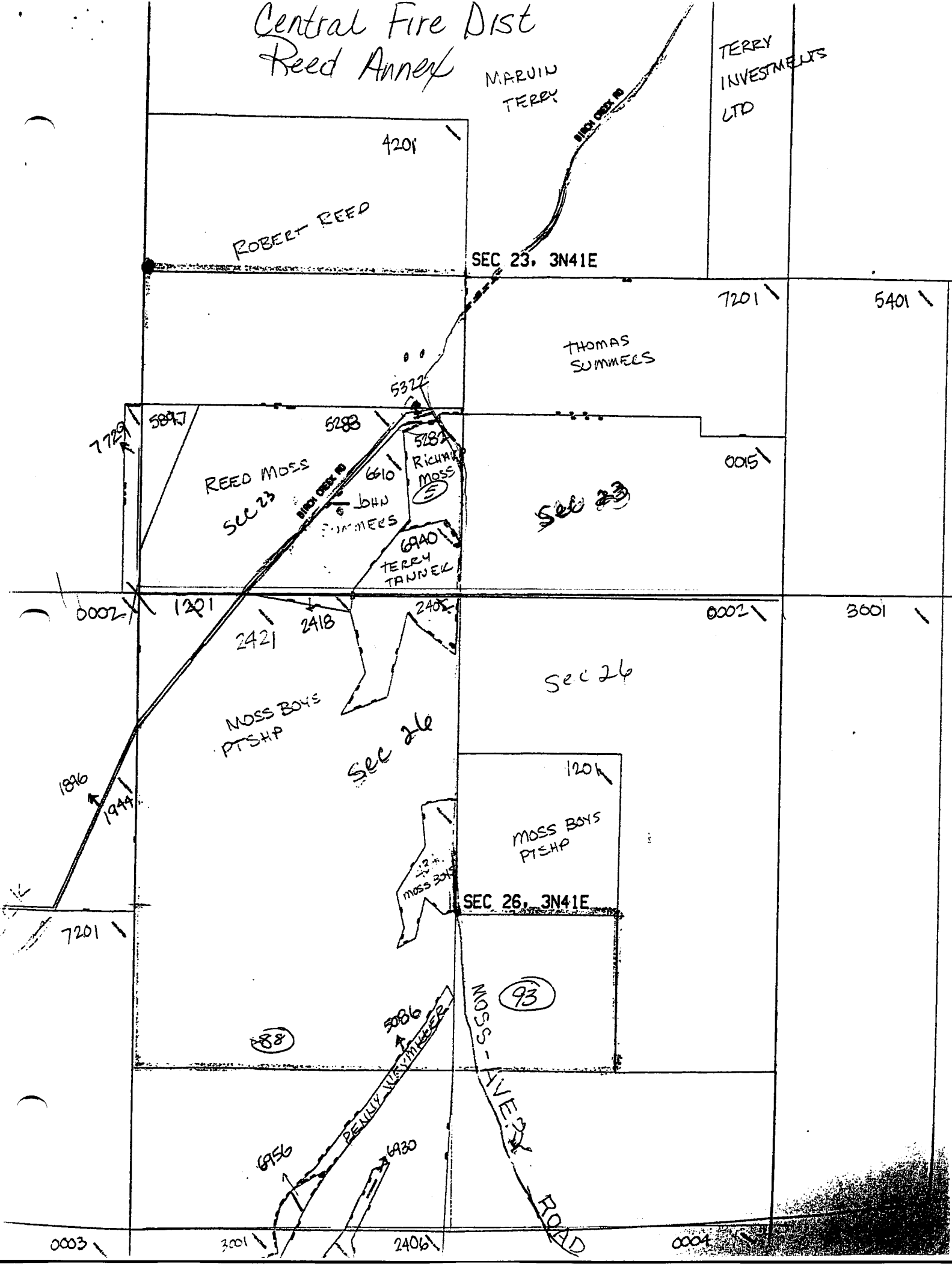

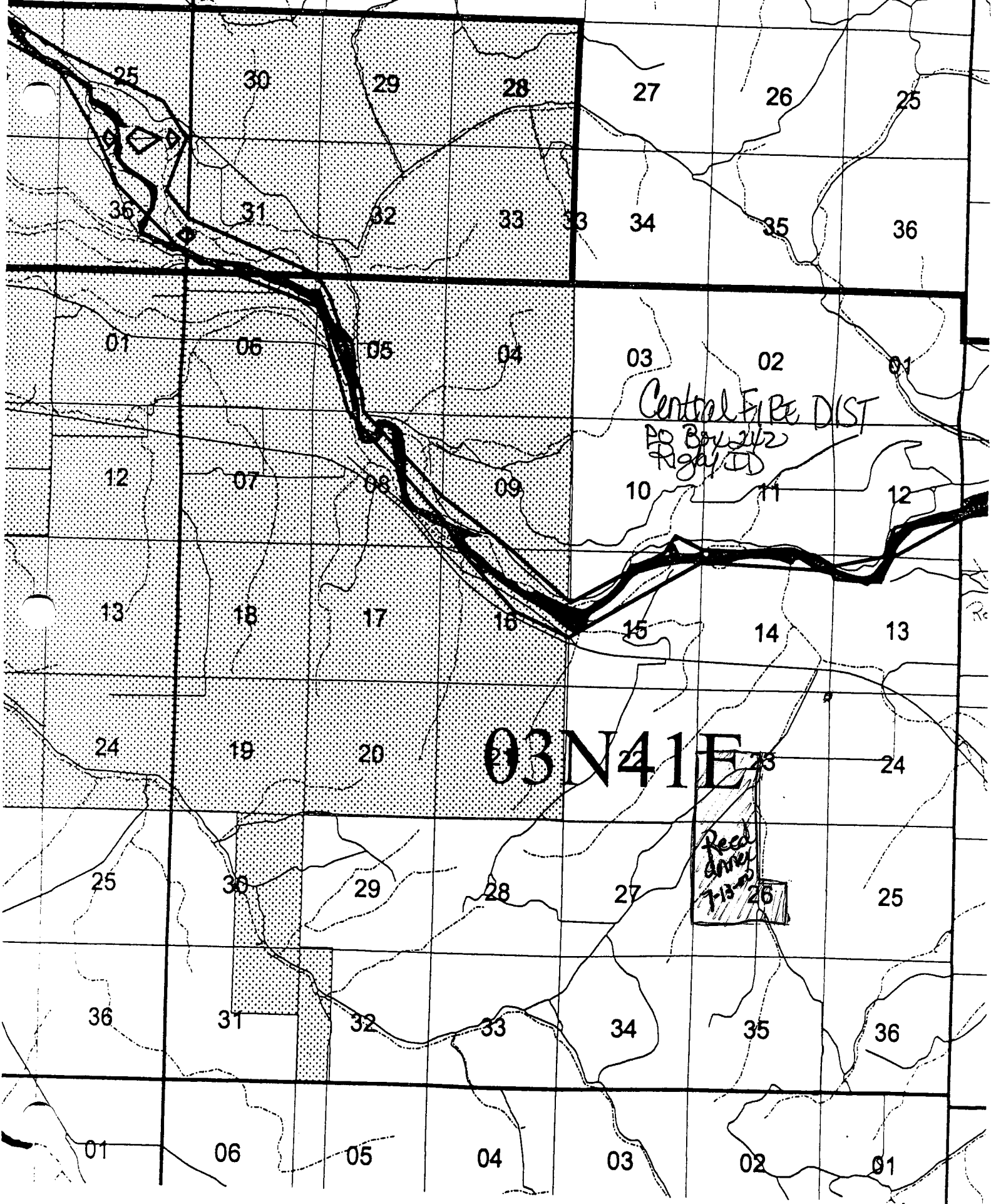
