

RESOLUTION NO. 10-02

**A RESOLUTION OF BONNEVILLE COUNTY, IDAHO, APPROVING
A SUMMARY OF ORDINANCE NO. 218-10**

BONNEVILLE COUNTY LIGHTING DISTRICTS NOS. 68-85 and 87-92 Inclusive

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BONNEVILLE COUNTY, IDAHO, as follows:

WHEREAS, on January 5, 2010, the Board of County Commissioners of Bonneville County (the "Board") adopted Ordinance Nos. 218-10, creating Bonneville County Lighting District Nos. 68-85 and 87-92 INCLUSIVE, AS FOLLOWS: NO.68 (RED ROCK ESTATES DIVISION NO. 2), NO. 69 (OLD MILL SUBDIVISION DIVISION NO. 2), NO. 70 (WARM SPRING MEADOWS DIVISION NO. 4), NO. 71 (CORNERSTONE COMMUNITY DIVISION NO. 3), NO. 72 (SUMMIT PARK DIVISION NO. 7), NO. 73 (CORNERSTONE COMMUNITY DIVISION NO. 2), NO. 74 (AMMON-LINCOLN INDUSTRIAL PAK, DIVISION NO. 3), DISTRICT NO. 75 (CALICO SKY SUBDIVISION DIVISION NO. 3), NO. 76 (WOOD RIVER ESTATES DIVISION NO. 1), NO. 77 (CALICO SKY SUBDIVISION DIVISION NO. 4), NO. 78 (FALL CREEK SUBDIVISION DIVISION NO. 4), NO. 79 (WARM SPRING MEADOWS DIVISION NO. 5), NO. 80 (CLOVER CANYON SUBDIVISION DIVISION NO. 1), NO. 81 (TIMBERLINE ESTATES DIVISION NO. 2), NO. 82 (CRIMSON VALLEY SUBDIVISION DIVISION NO. 4), NO. 83 (OLD MILL SUBDIVISION DIVISION NO. 3), NO. 84 (SUMMIT PARK DIVISION NO. 8), NO. 85 (RED ROCK ESTATES DIVISION NO. 3), NO. 87 (SUMMIT PARK DIVISION NO. 9), NO. 88 (TIMBERLINE ESTATES DIVISION NO. 3), NO. 89 (CROW CREEK SUBDIVISION DIVISION NO. 1), NO. 90 (PHEASANT GROVE DIVISION NO. 1), NO. 91 (SWEET COUNTRY ESTATES DIVISION NO. 1 AND SWEET COUNTRY ESTATES DIVISION NO. 1 FIRST AMENDED), NO. 92 (RIDGE VIEW DIVISION NO. 1) (the "Districts"); and

WHEREAS, pursuant to Section 50-901A, Idaho Code, the County is authorized to publish, in lieu of the entire Ordinance, a summary thereof;


NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED, AND ORDERED as follows:

Section 1: The Board hereby approves the Summary of Ordinance No. 218-10, which Ordinance was adopted by the Board on the 5th of January, 2010, a copy of the Summary is annexed hereto marked as Exhibit "A" and is incorporated herein by reference.


Section 2: This Resolution shall take effect and be in force from and after its passage and approval.


