RESOLUTION NO. 10-08

A Resolution by the Bonneville County Board of Commissioners to Declare its Intention to Vacate County Road Right-of-Way in Road Map Area 3 of Bonneville County

WHEREAS, the Bonneville County Public Works Department has identified a public right-of-way no longer in the public interest that should be considered for abandonment and vacation; and

WHEREAS, the abandonment and vacation of any road or right-of-way will not eliminate access to public lands or water; and

WHEREAS, the abandonment and vacation of any road or right-of-way will not leave any real property without access to an established public right-of-way; and

WHEREAS, in order to consider roads and rights-of-way in a geographical proximity the County has been divided into several areas that will be heard separately; and

WHEREAS, Road Map Area 3 is bounded on the north by 33rd North from its intersection with the east bank of the Snake River to its intersection with Highway 26 and Highway 26 from its intersection with 33rd North to its intersection with 35th East, on the east by 35th East from its intersection with Highway 26 to its intersection with Taylor Mountain Road and Taylor Mountain Road from its intersection with 35th East to the County line between Bonneville and Bingham Counties, on the south by the County line between Bonneville and Bingham Counties from its intersection with Taylor Mountain Road to its intersection with the east bank of the Snake River and on the west by the east bank of the Snake River from its intersection with the County line between Bonneville and Bingham Counties to its intersection with 33rd North extended ;


NOW, THEREFORE, be it resolved by the Bonneville County Board of Commissioners that, in accordance with Section 40-203, Idaho Code, it hereby declares its intention to abandon and vacate the following described County road right-of-way in Road Map Area 3:


Road Right-of-Way No. 30: A 50 wide foot right-of-way, the centerline of which is more particularly described as beginning on the north line of Section 28 Township 1 North, Range 38 East of the Boise Median, said point being on the east right-of-way of Mitchell Circle as said road is shown on the First Amended Plat of Holiday Hills Subdivision Division No. 2, as said plat is recorded in Bonneville County, Idaho; thence in an easterly direction through Lot 9 Block 12 of said First Amended Plat of Holiday Hills Subdivision Division No. 2, a portion of the South Half of the Southeast Quarter of Section 21, T.1N., R.38E., a portion of the North Half of the Northeast Quarter of said Section 28, Lot 5 Block 1, Lots 6, 7, 16, 17, 18, 21 and 22 Block 4, and Lot 31 Block 2 of the First Amended Plat of Holiday Hills Subdivision Division No. 1, Lots 32 and 33 Block 2 of Holiday Hills Subdivision Division No. 5 to a point on the east line of said Section 28, said point located approximately 560 feet South of the Northeast Corner of said Section 28.

BE IT FURTHER RESOLVED by the Bonneville County Board of Commissioners that a public hearing to consider said road abandonments will be held at 10:00 am on June 30, 2010, in the Commissioner's Chambers.
