RESOLUTION NO.: 15-04

A RESOLUTION OF THE BONNEVILLE COUNTY BOARD OF COMMISSIONERS EXPRESSING THE APPOINTMENT OF COMMITTEE TO OVERSEE COURTHOUSE SIGNAGE AND PLACEMENT OF FURNITURE IN COURTROOMS AND COURT HALLWAYS.

WHEREAS no one individual or committee has been assigned the responsibility to oversee the furnishings of the courthouse or courtrooms or courtroom/courthouse signage,

WHEREAS, courtroom furniture is moved about randomly without regard to the dignity and decorum of the courtrooms and court hallways,

WHEREAS, paper signs are indiscriminately posted in the courtrooms and hallways,

WHEREAS, the dignity and appearance of the top floor of the Law Enforcement and Courthouse buildings needs improvement.

WHEREAS, the Administrative Judge and Bonneville County Commissioners jointly appoint and delegate the responsibility for the daily monitoring of all signage and movement of furniture to a Facility Committee. The Committee membership shall be 2 judges to be appointed by the Administrative Judge, the Chief Court Marshal or his designee, and a deputy clerk to be designated by the Elected Clerk.

NOW THEREFORE, The undersigned County Commissioners and Administrative Judge delegate the daily monitoring of signage and furniture movement to the above Facility Committee. The Facility Committee shall elect a chairperson among themselves. The governance of the committee will be determined by the committee members. The committee will meet on an as needed basis. The Facility Committee must secure the approval of the County Commission for any proposals to modify or change the existing signage or furniture placement that involves county funds.

IT IS ORDERED, All county and state courthouse personnel are hereby prohibited from posting signs or moving furniture in the courtrooms or hallways without first consulting or communicating with the chairperson of the Facility Committee. All furnishings and signage decisions must have the approval of the facility committee.

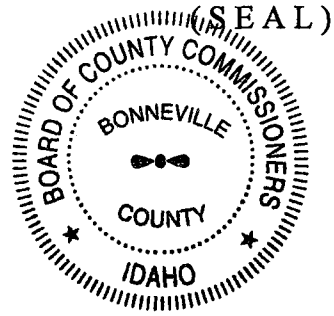
