**A JOINT RESOLUTION (No.16-06) OF THE BONNEVILLE COUNTY BOARD OF COMMISSIONERS WITH THE SUPPORT OF THE 7<sup>TH</sup> JUDICIAL DISTRICT PRESIDING BONNEVILLE COUNTY JUDGES CONCERNING THE DEDICATION OF THE CENTENNIAL COURTROOM TO ELECTED CLERK RONALD LONGMORE.**

WHEREAS, Ronald Longmore has been the longest-serving official in the history of Bonneville County, serving as Elected Clerk of the District Court for over 37 years from July 2, 1979 until his retirement on July 31, 2016 AND

WHEREAS, as part of his duties he served as the County Auditor and Budget Officer, Recorder, Clerk for the County Commissioners and Chief Election Officers during those years AND

WHEREAS, Ron has been known for the integrity and professionalism in executing his duties, having a keen knowledge of the Idaho Statutes, his strong support of the Idaho Judiciary System, and has been willing to use those skills to mentor other newly elected clerks in many counties for over 3 decades, AND

WHEREAS, as the District Court Clerk and judicial officer, Ron has shown his respect for our county as being a nation of law which values individual freedom with respect for its Citizens, AND

WHEREAS, the judiciary symbolizes this truth, and no other room in the courthouse better represents respect for the law and the dignity of the American Judicial system than does the Centennial Courtroom in the Bonneville County Courthouse.

THEREFORE, The Board of Bonneville County Commissioners, with the support of the Bonneville County Presiding Judges, finds it fitting that the Centennial Courtroom, a historical room that continues to provide a public forum for the resolution of disputes, be known as the **Ronald Longmore Centennial Courtroom** recognizing his years of exemplary services as the Bonneville County Clerk of the District Court.
