

RESOLUTION NO. 99-06

**A RESOLUTION OF BONNEVILLE COUNTY, IDAHO, APPROVING
A SUMMARY OF ORDINANCE NOS. 196-99**

BONNEVILLE COUNTY LIGHTING DISTRICTS NOS. 26-32

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BONNEVILLE COUNTY, IDAHO, as follows:

WHEREAS, on October 13, 1999, the Board of County Commissioners of Bonneville County (the "Board") adopted Ordinance Nos. 196-99, creating Bonneville County Lighting District No. 26 (Green Oak Meadow, Division No. 1), Bonneville County Lighting District No. 27 (Centennial Ranch, Division No. 6), Bonneville County Lighting District No. 28 (Cornerstone Community, Division No. 1), Bonneville County Lighting District No. 29 (Warm Springs Meadow, Division No. 1), Bonneville County Lighting District No. 30 (Fall Creek Subdivision, Division No. 2), Bonneville County Lighting District No. 31 (Miller Country Estates, Division No. 3), Bonneville County Lighting District No. 32 (Lincoln Park Subdivision, Division No. 5) (the "Districts"); and

WHEREAS, pursuant to Section 50-901A, Idaho Code, the County is authorized to publish, in lieu of the entire Ordinance, a summary thereof;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED, AND ORDERED as follows:

Section 1: The Board hereby approves the Summary of Ordinance No. 196-99, which Ordinance was adopted by the Board on the 13th day of October, 1999, a copy of the Summary is annexed hereto marked as Exhibit "A" and is incorporated herein by reference.


Section 2: This Resolution shall take effect and be in force from and after its passage and approval.
